Hearing of Citizens:

Eva Grecco, De Vries Park tenant, Apt. #15D stated that Board spoke about Non-Smoking Policy but nothing listed on Meeting Agenda.

Executive Director stated that his response was related to a question and no action was required.

Eva Grecco then stated, "OK," because she did notice Non-Smoking Policy was mentioned in the the Authority's 5-Year/Annual Plan but there was no rationale given to De Vries Park tenants after a meeting several months ago.

Executive Director stated that all tenants will receive fresh notice pertaining to Non-Smoking Policy. Eva Grecco stated, "OK, I will wait until I receive the notice."

Eva Grecco said that on Agenda it states "Closed Session," but if individual is on Closed Session they have right to be there, only when discussing the individual, anything else, that individual must leave "Closed Session." – "OK, that's all I have now."

Nicole Grecco, 140 Central Avenue, Lodi stated that on numerous occasions when visiting her mother, Eva Grecco, DVP, Apt. #15D, the alarm on Building #15 and sometimes other buildings went off and there was no response by the Lodi Fire Department because there is no activation at the Fire Department and that they only responded after she (Nicole) called.

The Deputy Executive Director, Gary Luna, explained that the fire alarms at De Vries Park are not direct wired to the Fire Department/Stations and tenants are expected to call in. He further explained that notices have previously been sent to all DVP tenants reminding them of their responsibility to call but stated that another reminder notice will be issued to all DVP tenants.

Nicole Grecco questioned the curb in front of the Administration Building was yellow and no painted gray. Gary Luna explained that after talking with the Chief of Police and since this is LHA-owned property, LHA has the right to do this.

Nicole Grecco stated that she was just concerned because a fire hydrant is at the end of the curb in front of the Administration Building and if Lodi Fire Department responded use that hydrant then they may have to run hoses around and between parked cars. Gary Luna thanked her for her concern and stated that LHA will take her recommendation into consideration.

Counsel, at this time, stated that after further review of his Agenda, he noticed two (2) items that can be discussed in the public, which are:
